General Update on Palestinian Political Prisoners

Since January 1st, 500 Palestinian administrative detainees have been boycotting Israeli military courts under the campaign "[Our Decision is Freedom ... No to Administrative Detention](#)". This includes the initial judicial review to uphold the detention order, as well as appeals and later sessions at the High Court. That means both the detainee and their lawyer are refusing to attend court sessions.

Now, the Palestinian administrative detainees in Ofer, Megiddo, and Naqab prisons **are escalating their boycott, increasingly taking collective and coordinated actions** like refusing meals or medicine for the day or the week. Their boycott highlights the struggle of thousands of Palestinian political prisoners imprisoned by the Israeli military judicial system, which sustains Israel's violent apartheid regime.


Objection submitted by Palestinian organizations against Israeli Military Commander's decision to declare them "unlawful"

The objection submitted by the groups' legal team follows the Israeli authorities' repeated refusal to reveal the alleged "secret evidence" against the organizations.

The organizations emphasized that **the Israeli authorities' declarations are blatant and extreme violations of international law**, as they deny the Palestinian people the realization of the most basic standards of self-determination.

"Eyewitness Palestine is committed to bringing Palestine to you, both while travel is not permitted and because not everyone has the ability to travel to Palestine."


